2022 Leadership Summit

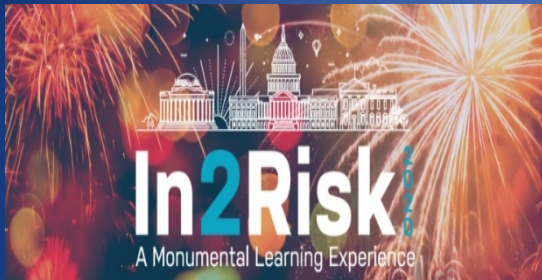


- The Leadership Summit is back, in-person, for 2022 at the Flamingo Hotel in Las Vegas, Nevada.

The Summit will be held on Thursday, April 28 and Friday, April 29, 2022; with an added day of training for Society Volunteers on Saturday, April 30, 2022.

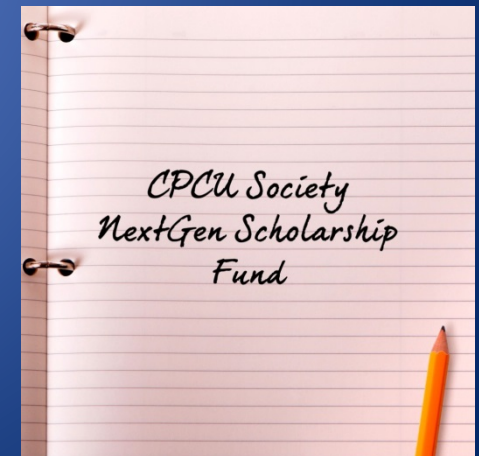
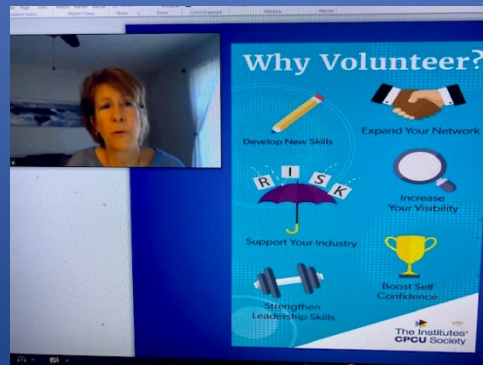
